FAMILY INVOLVEMENT

Participation in community activities such as church, volunteering, youth activities, athletics, organizations, or other activities.

RULES OF ELIGIBILITY

- Traditional families, step-families, single parent, and adopted families are eligible for nomination.
- Nominated families must live in Jefferson or Shelby counties.
- Family members need not live under the same roof, but must function as a family, demonstrating the listed criteria.
- · Nominators may nominate only one family per year.
- · Nominated families must sign the publicity release.
